## 3. How We Share Your Information

We do not sell your personal information. However, we may share your information with third parties in the following circumstances:

- **Service Providers:** We use Firebase as a backend to store and manage data, including user accounts, brokers, and messages. Firebase complies with industry-standard security protocols.

- **Legal Requirements:** We may disclose your information if required by law or in response to valid legal processes.
  - **Business Transfers:** In the event of a merger, acquisition, or sale of assets, your information may be transferred to the new entity.
